Overview

We are currently recruiting for a **Sanitarian** to support our environmental health programs. Appointment may be filled at the I or II levels, depending upon qualifications as listed within this advertisement.

This is a working field professional in environmental health. Primary responsibilities at both levels include enforcement of the Public Health Code, and statutes pertaining to environmental health. Duties include but is not limited to septic system permit application review, inspection, and site investigations, private well permit review, nuisance complaint investigation, environmental investigations, daycare inspections, public pool inspections, campground inspections, and food establishment inspections. The position reports to the Chief Sanitarian.

What You Should Bring

The ideal candidate for this position will have a passion for local governmental service in the area of environmental health, while working in a team environment.

While applying excellent communication skills, the ideal candidate will take a compassionate, empathic, educational approach to local code enforcement without compromising public health and public health related laws and regulations.

Education: Both levels require a minimum a bachelor's degree from an accredited college or university in Environmental Health, Public Health, or related field

Experience:

- **Sanitarian I:** Two years of experience in the field of environmental health or related field. Consideration may be given to equivalent training and experience.
- **Sanitarian II:** Three years of experience in the field of environmental health or related field. Consideration may be given to equivalent training and experience.

Special Requirements

Both levels of **Sanitarian** require a Phase I and II Subsurface Sewage Disposal Certification

from the State of Connecticut as well as a Food Establishment Inspector Certification from the State of Connecticut.

Sanitarian II would additionally require a license as a Connecticut Registered Sanitarian as well as to be qualified as a lead inspector.

The Opportunity

This is a minimum 37 hour a week job. There will be some scheduled weekend inspections and on call coverage obligations. The Sanitarian I position is non-exempt and the Sanitarian II position is exempt.

Total Compensation

Besides the salary, we offer an amazing benefits package. We offer a choice of PPO or HDHP medical plans. We participate in a defined contribution 401 retirement plan, and a voluntary 457 retirement plan.
