Membership types: **Active, Corporate, Student, Retired and Honorary.**

Active - an individual, active in the profession of environmental health or related activities, having a genuine interest in public or environmental health and who shall promote the aims and objectives of the Association.

Corporate - a for profit company or corporation having a genuine interest in public or environmental health.

Student - a resident of Connecticut who is enrolled full- time in an institution of higher learning in or outside of the State in a program relating to environmental health, or a non-resident of Connecticut who is enrolled full-time in an institution of higher learning in Connecticut in a program relating to environmental health.

Retired- A retired membership may be awarded to any Active member who has been a member of the Association for at least five (5) consecutive years preceding retirement, has accrued at least ten (10) years of environmental service, and has retired due to age or disability. Retired members shall enjoy the same rights and privileges as Active members.

Honorary - Awarded by vote of the Executive Board. To qualify, an individual must have rendered distinguished or exceptional service in the field of environmental health who has been recommended for honorary membership by a two thirds vote of the Executive Board.
